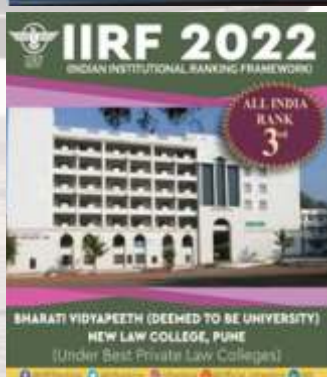

steps against the harassment faced in workplaces or any other places. The skit was performed in presence of the guest of Avalara company and the student of the college.

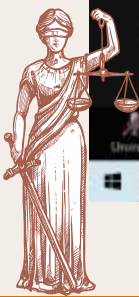
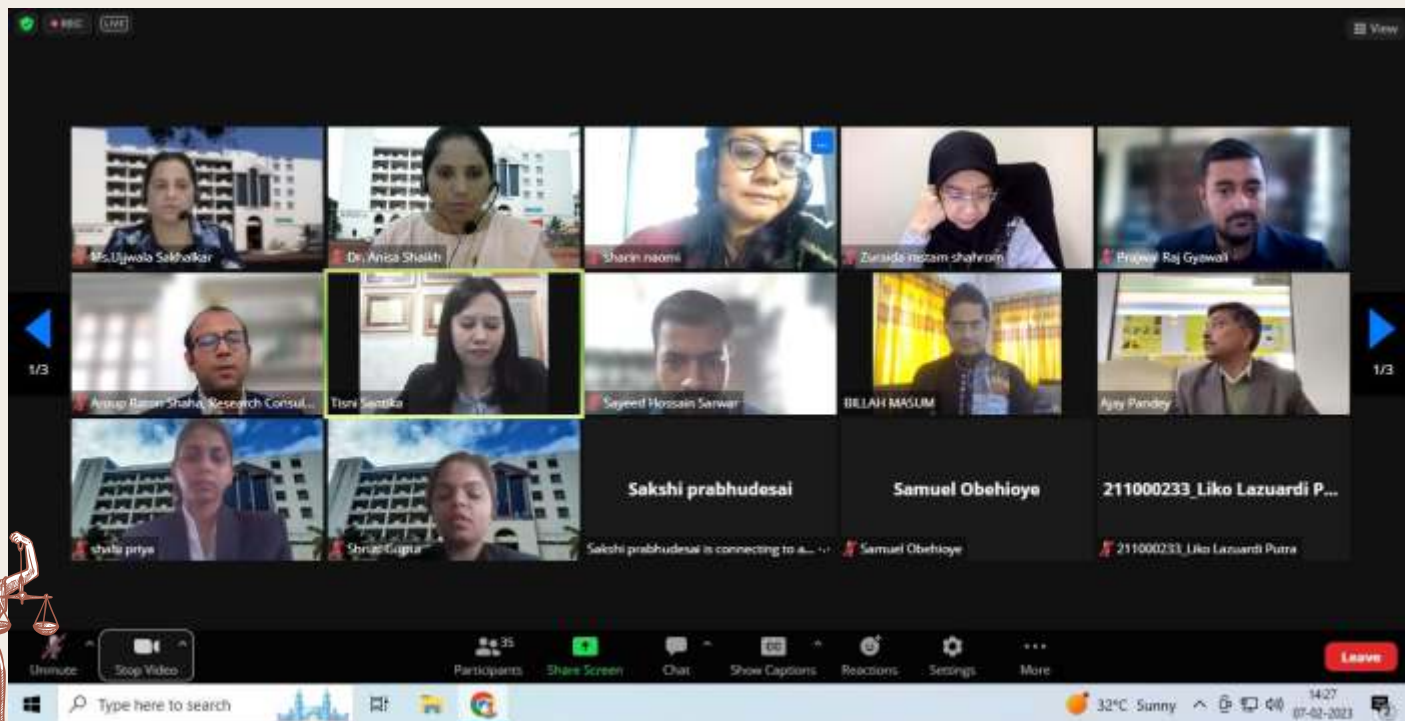

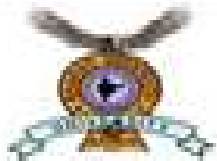
