A country's capacity to produce wealth depends upon many factors, most of which have an effect on one another. Wealth depends to a great extent upon of a country's natural resources such as coal, gold and other minerals, water supply and so on. Some regions of the world are we supplied with coal and minerals, and have a fertile soil and a favourable climate, other regions possess perhaps only one of these things, and some regions possess none of them. The U.S.A. is one of the wealthiest regions of the world because she has vast natural resources with her boarders, her soil is fertile and her climate is varied. The Sahara Desert, on the other hand, is one of the least wealth.
