ABOUT ONLINE REFRESHER COURSE

Refresher Courses for teachers aimed to advance the quality of teaching and research in social sciences or different academic disciplines both at the graduate and post-graduate levels. The College affiliation is approved by Bar Council of India through Letter No. BCI-D-1029,(2009(1-E.Mtg) Dated 7/7/2009. The college is also recognized under 2f & 12b of UGC Act 1956. The college is Re-Accredited with "A+" Grade by National Assessment & Accreditation Council (3rd Cycle). The college was inaugurated in the year 1978 at the hands of Hon. Mr. Justice Y.V. Chandrachud the then Chief Justice of India. The foundation stone of the New Law College building was laid down in the year 2004 at the hands of the Chief Justice of India Hon. Mr. Justice K.G. Balakrishnan, the then judge Supreme Court of India. The new building of the law college was inaugurated in the year 2005 at the hands of Hon. Mr. Justice R.C.
