
MEMORANDUM OF UNDERSTANDING

BETWEEN

BHARATI VIDYAPEETH NEW LAW COLLEGE, PUNE

AND

MEMO PUNDITS

THIS MEMORANDUM OF UNDERSTANDING ("MoU") is entered into on this [Insert Date] day of August 2019 (the "**Execution Date**"), by and between Memo Pundits ("**MP**") and Bharati Vidyapeeth New Law College, Pune ("**BVP**").

MP and BVP shall hereinafter individually be referred to as a "Party", and collectively as the "Parties", as the context may require.

WHEREAS:

- A. MP is involved in conducting a course titled "Drafting, Editing and Formatting of Moot Court Memorials" ("**Course**");
- B. BVP desires to conduct the Course for its students; and
- C. MP and BVP desire to enter into a long term association for conducting the Course in accordance to the terms and conditions set forth in this MoU.

NOW, THEREFORE, the Parties hereby agree as follows:

1. CONDUCTING THE COURSE

MP and BVP agree to cooperate, collaborate and organize the Course in accordance with the following terms:

- 1.1. The Course shall be conducted at least once every year;
- 1.2. The dates for the Course shall be finalized mutually by both the Parties, one month in advance;
- 1.3. BVP shall allow the use of its facilities including auditoriums, conference rooms, lecture rooms, seminar rooms, guest house and other facilities for the purpose of conducting the Course;
- 1.4. The Course shall be conducted within a span of 2-3 days; and
- 1.5. The Course shall be conducted for a minimum of 300 students of BVP.

2. ADDITIONAL SERVICES PROVIDED BY MP

- 2.1. In addition to providing the Course to the students of BVP, MP agrees to conduct an yearly memorial screening process for 3 teams of BVP participating in reputed moot court competitions.
- 2.2. The timings and dates for the memorial screening process shall be mutually decided by the Parties.
- 2.3. The memorial screening process shall exclusively deal with editing and formatting portions of the memorial.

3. COURSE FEE AND OTHER COMMERCIALS

- 3.1. BVP understands that the standard fee structure of the Course provided by MP is:
 - (a) INR 500 per student where the number of students is below 200; and

6.3. Each party will treat information provided by the other as confidential and will not divulge it to any third party without any prior consent of the other party to this MoU.

7. COMMENCEMENT, TERM, RENEWAL AND TERMINATION

7.1. This MoU shall become effective on the date of signing by both the parties and shall remain valid thereafter for a period of one year from the date of signing by the representatives of each Party who is authorized to sign on behalf of that Party.

7.2. After expiration of the one year period, the MoU may be renewed, along with mutually agreed alternations, for a future period for as long as the Parties decide.

7.3. The MoU may be terminated by either party at any time by giving three months prior written notice to the other party.

7.4. Two originals of this MoU have been prepared in English, to be signed by the appropriate officials from the participating institutions. Each of the institutions will retain for its records one original.

8. GOVERNING LAW

This MoU shall be governed by and construed in accordance with Indian law. All the matters arising out of this MoU shall be subject to the exclusive jurisdiction of the courts at New Delhi, India.
