### The Advance Exploration, Training of Intellectual Property & Cyber Law Cell (AETIP & CL Cell)


Congratulations – the Cell has been approved by the Bar Council of Maharashtra & Goa Two Day Faculty Development Program on IPR


# Workshop on "INTELLECTUAL PROPERTY RIGHTS -PATENTS & DESIGNS PROCESS"

We had various eminent speakers from different walks of the Legal Fraternity imparting knowledge and training our students to face the challenges of tomorrow. The Day 1 session was chaired by



Mr. Sanjay Jadhav Supt. Police Highway Mumbai who spoke on the modalities of cyber crime types and Precautions, the do's and don'ts with respect to the internet and cyber world. Session 2 was chaired by Adv. Ms. Ayushi Mishra, Cyber and Trademark Lawyer who spoke on the Role of Intermediary, Social Networking sites, Data Protection Bill and Smart Crimes. She elaborated on the Personal Data Protection Bill. Day 2 Session 1 was chaired by Adv. Vaibhav Salunkhe Consultant & Gazetted Trainer, Kolhapur Range (R5) Maharashtra Police. He spoke on Practical Aspects in relation to Proceedings before the Adjudicatory Officer & Department of Information Technology. He drew attention to the role of Adjudicatory Officer, Department of Information Technology. Day 2 Session 2 was chaired by Dr. Sanjay Tungar PI Cyber Cell Pimpri Chinchwad. He spoke on the number of crimes committed on the internet and he educated the students to beware of the different ways used by criminals to lure their victims on the internet. He also stated certain challenges faced by the law enforcement machinery in nabbing criminals. Day 3 Session 1 was chaired by Mr. Sandip Gadiya, Cyber Crime Investigation Expert who has handled a number of cyber crime investigations for the law enforcement agencies. His session encompassed the different types of Cell Phone crimes and how cell phones are used to commit crimes. Day 3 Session 2 was chaired by Adv. Ashish Sonawane who spoke of IPR on the internet and the various Domain issues. Further the mechanism of settlement of disputes in the cyber world. He cited various case laws of prominent business houses and the misuse of their Intellectual Property by cyber criminals. Day 4 Session 1 was chaired by Adv. Nishant Katneshwarkar, Advocate Supreme Court, who gave an insight into the procedural tour of the Supreme Court with respect to Cyber law disputes.




#### Panel Discussion on "Role of Law Schools in Community Development: A Roadmap for the Future



A live telecast of the event from New Delhi was made during the inauguration ceremony, where eminent personalities such as Indian President Ram Nath Kovind, CJI N.V. Ramana and Justice Lalit explained the importance of legal aid and how such issues are essential for legal practices. The message of the event was that everyone in this profession has to work towards the spread of legal awareness and further to provide free legal aid to the people in need. The District Judges present at the Pune venue, too gave impactful inputs emphasizing on the important role of colleges, which boosted the morale of students as well as gave a head start to the month-long campaign.

#### **Lecture Series on Women Empowerment**







On 5th October 2021 Women Empowerment Lecture Series was organised at Mahatma Phule Nagar, Dapodi, Pimpri-Chinchwad, Pune. There were 25 participants who participated to spread legal awareness and educate the women of their basic rights, provide strong supportive measures to curb domestic issues and provide information on NALSA, DLSA. The centre distributed pamphlets in this respect. Faculty members and students of B.A.LLB. 3rd Year namely Anaya Mapari and Utkarsh Bhushan Pandey conducted lectures for women working for an NGO namely 'Bahujan Hitay.' The topic of their lectures revolved around 'Basic women's rights and sexual harassment of women in the workplace'. The faculty who delivered the lectures were Dr. Sagar Shelke, Assistant Professor. The session concluded with an interaction with the audience who indulged in brainstorming questions regarding the topic of women's safety, domestic issues and financial issues as well. This session was beneficial for most women as they were unaware of the fact that issues can be resolved out of court as well.

#### Lecture series on "Who is entitled to Free Legal Aid?"



On 6th October 2021, a lecture series on "Who is entitled to Free Legal Aid?" was organised at Pirangut. There were 20 participants who took part in the spread of legal awareness among women working as domestic help in the village of Pirangut. The faculty and students from B.A. LLB. 3rd Year namely Anaya Mapari and Utkarsh Bhushan Pandey conducted lectures on how legal aid acts as a link between underprivileged class of people, especially the women class. This outlined the legal system of the country to them. The topics of the lectures were: need for legal aid, who is entitled to free legal aid, the procedural aspects of conducting and receiving legal aid and what its benefits and outcomes are?

Dr. Salil Shringarpure, Assistant Professor, further explained the different crimes that take place against womankind and gave a detailed account of the procedure to act against those crimes. Lastly, there was a session regarding the topic of women's safety, domestic issues, the implementation of the Code of Criminal Procedure and the Indian Penal Code. The speakers were successful in educating the women as well as their children who were also present there. They were enlightened on issues such as provisions as to basic maintenance to them and their ward.

#### **Lecture series on NALSA, DLSA**

On 19th October 2021 Lecture series on NALSA, DLSA and services were conducted at Ambedkar Colony, Pimpri Colony. There were 20 Participants. The basic aim was to spread legal awareness about NALSA, DLSA and New Law College Legal Aid Centre through the distribution of pamphlets. #### **Databases Demonstration**


