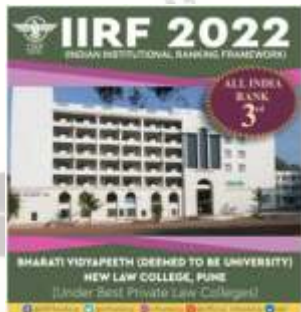

The session was conducted on 16th September 2022 in Offline Mode at Abhijeet Auditorium, New Law College, Bharati Vidyapeeth University, Pune. The resource person Dr. Putul Sathe spoke on gender laws. Dr. Sathe stated that Equality rights are formally guaranteed in Articles 14, 15, and 16 of the Indian Constitution. But as feminist jurisprudence has pointed out the formal approach to equality has been dominated within the Constitutional law and fragments

of substantive equality have been identifiable. In the formal approach, equality is seen to require equal treatment and gender difference has been approached through the following approaches: protectionist, sameness, and corrective. It is in this context that the concept of substantive equality approach points not to the equal treatment of law, but rather to the actual impact of the law. The focus of the analysis is not on sameness or difference, but rather on disadvantage.

## Legal aid awareness program regarding Wearing Helmet and following Traffic Rules



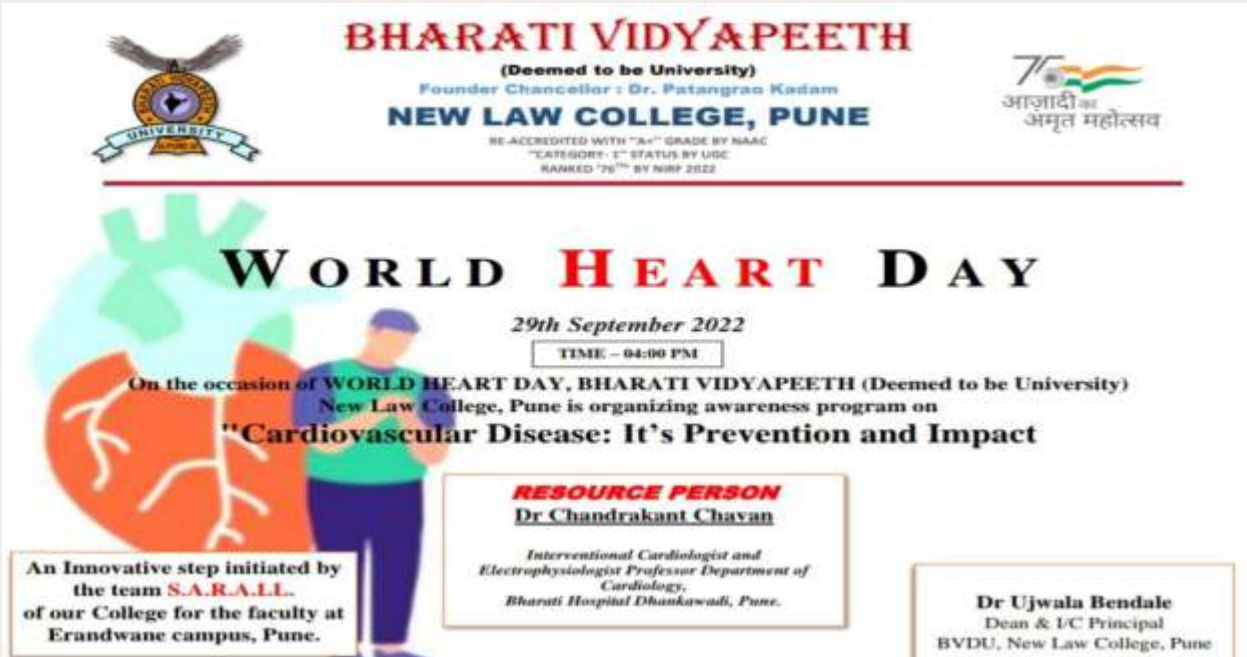
